

**ORDINANCE NO. 0-2016-798**

**AN ORDINANCE REPEALING CURRENT SECTION 71.06 OF THE CODE OF ORDINANCES AND ADOPTING A NEW SECTION 71.06, NO PARKING ZONES, TO CHAPTER 71, STOPPING, STANDING, AND PARKING, OF THE CODE OF ORDINANCES TO SPECIFY NO PARKING ZONES AND RELATED RESTRICTIONS AND INCLUDING A PENALTY OF A FINE NOT TO EXCEED \$500 FOR VIOLATIONS**

WHEREAS, the City Council has adopted various ordinances governing parking on city streets; and

WHEREAS, the City Council recently adopted Ordinance O-2016-794 repealing Section 73.01 of the Code of Ordinances and adopting a new Section 71.06 of the Code of Ordinances to govern parking on various streets in the City; and

WHEREAS, the City Council has determined that provisions in Section 71.06 concerning parking on Binz-Engleman and on Boatman should be modified and that Hickory Hill should be listed once on the list of streets and that the current Section 71.06 should be repealed and replaced by a new Section 71.06 of the Code of Ordinances.

NOW, THEREFORE, it is ordained by the City Council of the City of Kirby, Texas, that:

Section 1. Section 71.06 of the Code of Ordinances as adopted by Ordinance No. O-2016-794 is hereby repealed.

Section 2. New Section 71.06 of the Code of Ordinances is hereby adopted to read as follows:

**Section 71.06 - NO PARKING ZONES**

(A) The following locations and streets are designated “No Parking Zones” subject to the Restrictions set out in Subsection (B) of this Section 71.06.

(B) Parking Restrictions Defined: All streets and other roadways within the incorporated limits of the City of Kirby shall be subject to one or more of the following restrictions.

Restriction A No parking for any vehicle on the street

Restriction B No commercial vehicle parking. Boats, RV's, motor homes, and other recreational vehicles may not be parked in the street. No junk or abandoned motor vehicles (as defined in Chapter 90 of the Code of

Ordinances) may be parked or stored on the street. Repair work, except repairs necessitated by an emergency, is prohibited.

Restriction C Unrestricted parking for non-commercial cars and light pick-up trucks not exceeding one ton cargo capacity.

Restriction D Limited Parking may be permitted under one of the following conditions:

1. Limited parking not to exceed 30 minutes is allowed for commercial delivery. The driver must have an invoice or other bill of lading indicating a delivery at a specific address with the incorporated limits of the City of Kirby.
2. Limited parking is allowed for service vehicles while work is in progress (*e.g.*, hot water heater or air conditioning repair or replacement).
3. During the period of a yard sale, limited parking is allowed for those homeowners who have purchased a City of Kirby Yard Sale Permit.
4. Limited parking is allowed on recognized federal or state holidays.
5. Limited parking may be authorized at the discretion of the Chief of Police

Restriction E No parking for any vehicle on the north side of the street

Restriction F No parking for any vehicle on the south side of the street

Restriction G No parking for any vehicle on the east side of the street

Restriction H No parking for any vehicle on the west side of the street

Restriction I Fire Lane - No Parking

- (C) The provisions of this schedule prohibiting the parking of a motor vehicle shall apply at all times except when it is necessary to stop a vehicle to avoid conflict with other traffic or in the compliance with the direction of a police officer or traffic-control device.
- (D) Any vehicle that shall be found parked in violation of this schedule, shall be immediately removed to and impounded in the police automobile pound or other designated location provided by the city for such purposes, by any police officer, or other persons duly authorized and acting under and by authority and direction of any member of the Police Department.
- (E) Any vehicle removed and impounded under this schedule shall be towed to the police automobile pound or other designated location that has been provided for the storage of such vehicles. Such vehicle shall be retained and held by the Police Department at such pound facility until all charges for towing and storage against such vehicle shall have been paid to the city, to reimburse the city for the expense

of towing and storing such vehicle. The daily storage fee for such vehicles shall be \$20.00 per day until claimed by the owner or duly authorized agent.

- (F) It shall be an offense to park any vehicle in such a manner that it blocks access to any mailbox, a driveway, or the entrance to any parking lot or other property.

Section.3. A violation of this ordinance shall be punished by a fine not to exceed \$500. Each day a violation of this ordinance shall occur shall constitute a separate offense.

Section 4. This ordinance shall be effective on passage and adoption.

PASSED and ADOPTED on the 13th day of October, 2016, the second reading being dispensed with by the affirmative vote of all the Council members present.
